

BACKGROUND


- Europe is ageing—longer lives reflect the success of strong health systems.

ACTION POINTS:


- Create a **pan-European translational health ecosystem**



- **Should Europe invest in an 'European Silicon Valley for Health' with risk-tolerant sustainable investments and capital?**




